Central Coast Classes

(San Luis Obispo and Santa Barbara Counties)



BSIS Firearm Course 16 Hours

This course meets the requirements of the California Bureau of Security and Investigative Services for Security Guards, Private Investigators, and Alarm Agents to carry a firearm while on duty.



California CCW Class 8 Hours

This course meets the requirements of the San Luis Obispo County Sheriff in order to apply for a CCW permit.



Utah and Florida CCW Class 4 Hours

This course meets the requirements for non-residents of Utah and Florida to obtain a CCW permit that is accepted in up to 32 states.



Introduction to Handguns 4 Hours

This course covers gun safety, hand gun functions, and practical shooting. There are women only classes available and also private classes for law enforcement officer's spouses.

Family Gun Safety Class 2-4 Hours

By appointment only. This course is designed to teach every family member gun safety and how to safely handle every gun in the household.

BSIS Firearm Course 16 Hours

This course meets the requirements of the California Bureau of Security and Investigative Services for Security Guards, Private Investigators, and Alarm Agents to carry a firearm while on duty. This class is held at the College of the Sequoias in Visalia.



California CCW Class 4 Hours

This course meets the requirements of Department of Justice, Kings and Tulare Counties for CCW permits. These classes are held at the College of the Sequoias in Visalia and at the Porterville Veterans Memorial Building in Porterville every month.



Utah and Florida CCW Class 4 Hours

This course meets the requirements for non-residents of Utah and Florida to obtain a CCW permit that is accepted in up to 32 states. This class is held at the Exeter Veterans Memorial Building in Exeter every month.
